As per the decision made at the SLAS Administrative Committee meeting held at the Sports Ministry's Duncan White Auditorium on 22nd January 2026, chaired by the Director General of Sports

9.2 Renewal of License

The previous version of **Section 9.2** is invalid until 31st December 2026. And it will be re valid from 1st January 2027. The amended version of **Section 9.2** will be applicable from 27th January 2026 and validity will remain until 31st December 2026 as follows:

9.2.1 Age Below 17

- **Medical Requirement:**
 - Medical Declaration Annex 02.
 - ECG Report (Performed and endorsed by a doctor).
- **Additional Requirements:** Annex 01, Annex 04, Annex 03 (if applicable), and Annex 05.

9.2.2 Ages 45 and Above

- **Medical Requirements:**
 - NTMI Medical Check-up or Annex 02 Medical Declaration.
 - Exercise ECG Report (Performed and endorsed by a doctor).
- **Additional Requirements:**
 - Application Form (Annex 01, Annex 04, Annex 03, and Annex 05, 02[if applicable]).

9.2.3 Between Ages 17 to 45

- **Medical Requirements:**
 - NTMI Medical Check-up or Annex 02 Medical Declaration.
 - ECG Report (Performed and endorsed by a doctor).
- **Additional Requirements:**
 - Application Form (Annex 01, Annex 04, Annex 03, and Annex 05, 02[if applicable]).

14. Group and Classes for Different License Categories

The amendment to **Section 14** will be applicable from 27th January 2026, as follows:

- **New Vehicle Category added:**
 - SLX 650CC. Eligible License Classes, Class B, Class A, and Class A-.

As per a decision made at the Special Emergency SLAS administrative Committee meeting held on 27th January 2026.

Drivers can now obtain **either** a [National Transport Medical Institute \(NTMI\)](#) medical certificate **or** an **Annex 02 Medical Declaration**—both are not required. The Annex 02 declaration must be performed and endorsed by an Institute of Sports Medicine (ISM) approved doctor or a **Sports and Exercise Medicine Physician**.

1.0 General Requirements

- 1.1** All competitors participating in any SLAS approved events, must possess a valid **Competition License** issued by SLAS.
- 1.2** SLAS may waive the license requirement for social events.
- 1.3** It is an offence for any licensed competitor to participate in unauthorized events.
- 1.4** SLAS is entitled to grant licenses to:
- Nationals of Sri Lanka
 - Nationals of other FIA member countries (with ASN approval)
 - Nationals of non-FIA countries
-

2.0 Eligibility for Competition Licenses

2.1 General Requirements

2.1.1 All applicants must be medically fit (Refer [Section 9.0](#)) and possess adequate knowledge of motor racing and its regulations.

2.1.2 Applicant applying for a competition license is deemed fit and capable of driving a competition vehicle at the time of submitting an application.

2.1.3 The minimum age for a Category C license is 14 years. (Age as of January 1st of the particular year).

3.0 Grades of Licenses

3.1 There shall be four grades of competition licenses:

- **Class (A): National**
- **Class (A-): National**
- **Class (B): National**
- **Class (C): National Novice**

3.2 A competitor may hold only **one** competition license grade at a time within January 1st to December 31st of a particular year.

4.0 License Conditions

4.1 The holder of a competition license shall:

- I. Be bound by the **National Sporting Code (NSC)** of SLAS (Effective from 1st January 2004).
 - II. Be bound by the **SLAS Appendix D** (Drivers Code of Conduct Effective from 1st August 2019).
 - III. Be aware of SLAS **Appendix R** (Penal Code Effective from 1st August 2019).
 - IV. Adhere to all regulations and documents published by SLAS and any supplementary regulations issued by the race promoter.
 - V. Be medically fit during competition and free of physical or mental disabilities.
 - VI. In the case of minors (under 18), submit written parental or legal guardian consent acceptable to SLAS.
-

5.0 Issue of Competition Licenses

5.1 The issuing of competition licenses shall be administered by SLAS.

5.2 The **Licensing Sub-Committee** shall recommend to the SLAS council, procedures for applications, renewals, and upgrades, prescribe medical and competition proof requirements, and license fees.

5.3 All licenses shall be issued, renewed, or upgraded under the scrutiny of the Sub-Committee.

5.4 The SLAS may withdraw or cancel a license with reasons stated. Appeals may be submitted to SLAS.

6.0 Criteria for Competition Licenses

6.1 Class C (National Novice License)

- Open to who has not obtained any other SLAS license category before.
- Can be held for a maximum of **3 years**.
- Competitors of the category must meet the following criteria to participate at gravel races.
 - Having participated and finished a minimum of **2 mass start events on tarmac**.

- In order to participate at the **Foxhill Supercross and Gunner's Supercross**, a competitor should have participated and finished a minimum of **2 mass start gravel races**.

6.2 Class- B (National)

6.2.1 To upgrade from **Class C to Class B** prior to the maximum validity period:

1. Applicants **must have obtained** a minimum of **20 points** from **gravel** events and **20 points** from **tarmac** events, **including** at least **two mass-start podium** finishes.
2. **OR** have a **total of 50 points** with **5 Mass Start finishes**.

6.2.2 Automatic upgrade Class C to Class B

Automatic upgrade occurs at the end of the 3rd year, if the criteria is met. If not, the SLAS will decide on the continuation or upgrade.

6.3 Class- A (National)

6.3.1 Upgrade from **Class B to Class A** requires:

- Gravel: Minimum **20 points** and Tarmac: Minimum **15 points** with **3 Mass Start** Events.
- **Or Total 40 Points** with **4 Mass Start** Events.

6.3.2 Upgrading from **Class A- to Class A**

- If a competitor decides to upgrade from A- National to A National, the particular renewal should be carried out before the 31st of January of the renewal year.
- Class A- license must **be held** for a minimum period of **two (2)** years.

6.4 Class – A- (National)

- Refer [Section 12](#) for downgrading

6.5 Applications

It is mandatory to submit duly filled **SLAS License Application (Annex 1 with relevant documents)**. The medical requirements must be fulfilled in accordance with [Section 9.0](#).

The SLAS reserves the rights to accept or reject any application if the required criteria is not met.

6.6 Written Test

The written test will be scheduled on the first working Tuesday in, January, March, May, July, September and November of each year depending of the availability of the venue, holidays

and the number of applicants.

7.0 Points System for Class C and B

- A points system will be introduced with effect from 01.01.2026. All license upgrades for the year 2026 will be based on this points system.
- The event must be recognized as a national event for points to be awarded.

7.1 Points for Gravel, Tarmac and Hill Climb Events

Finishing Position	Points
1 st	10
2 nd	8
3 rd	6
4 th	4
5 th	2
6 th and beyond	1

8.0 Validity of Licenses

A current license becomes invalid:

- a. From midnight on **31st December** of the year issued (unless extended by SLAS).
 - b. If the holder is found to be medically unfit through proper assessment.
 - c. If a driving license is revoked or suspended.

9.0 Medical Examination & Additional Requirements

9.1 First-Time License Holders

First-time license applicants must submit their application for the license at least 30 days prior to their first competition

9.1.1 Below Age 17

- **Medical Requirement:**
 - Comprehensive Medical Check-up. (Annex 02).
- **Additional Requirements:**
 - **Written Test** (compulsory for all new license holders).
 - Annex 01, Annex 02, Annex 04 and Annex 05.

9.1.2 Ages 17 & Above

- **Medical Requirements:**
 - NTMI Medical Certificate.
 - Exercise ECG Report (Performed and endorsed by a doctor).
- **Additional Requirements:**
 - **Written Test** (compulsory for all new license holders).
 - **Application Form** (Annex 1 and Annex 4).

9.2 Renewal of License

9.2.1 Below Age 17

- **Medical Requirement:**
 - Comprehensive Medical Check-up. (Annex 02).
- **Additional Requirements:**
 - Annex 01, Annex 04, Annex 3 (If Applicable) & Annex 5.

9.2.2 Ages 17 & Above

- **Medical Requirements:**
 - NTMI Medical Check-up.
 - Exercise ECG Report (Performed and endorsed by a doctor).
- **Additional Requirements:**
 - **Application Form** (Annex 1, Annex 4, Annex 3 & 5(if applicable)).

9.3 Additional Guidelines

- All medical examinations must be documented on the official medical form, signed by both the examining doctor and the applicant.
- License holders must report any illness or condition that may affect their fitness to compete before an event.

9.4 Medical Examinations Breakdown

- 9.4.1 NTMI Medical Examination:** Conducted by the National Transport Medical Institute.
- 9.4.2 Comprehensive Medical Check-up:** A medical examination as recommended by the Ministry of Sports (refer to Annex 2).
- 9.4.3 Exercise ECG (Exercise Stress Test Report):** "Exercise Stress Test Report" or "Exercise ECG Report". This report is generated by a doctor following the exercise ECG (also known as a stress test), which evaluates how the heart performs under physical stress.

9.5 SLAS Reserved the Rights:

To request a competitor to avail him/her self for a medical examination at any given time. In such instance, his/her competition license will be temporarily suspended until the medical is completed and the results are assessed.

10.0 License Fees

- 10.1 Fees for a new license application Rs. 15,000/-
 - 10.2 Fees for renewal of a license Rs. 10,000/-
 - 10.3 Request for license exams other than the pre-determined dates Rs. 25,000/-
-

11.0 License Producing

Competitors must surrender their competition licenses to SLAS or any of its affiliated clubs as and when requested at any SLAS-sanctioned event.

12.0 Downgrading of License

Upgrading is possible only from Class B National to Class A National, under the following conditions:

- 12.1 Downgrading a license is allowed only at the time of renewal.
 - 12.2. In case a competitor decides to downgrade the license, the particular renewal should be carried out before the 31st of January of the renewal year.
 - 12.3 Re-upgrade to **Class A** requires compliance with [Section 6.3](#) and should have held the **Class A**- license for a minimum of 2 years.
 - 12.4 **Class A** license must be held for a **minimum** period of **two (2)** years.
-

13.0 Temporary Licenses

13.1 Applicable for **National TSD Rallies ONLY**.

13.2 Fees: Rs. 5,000 valid until **31st December (Maximum 1 Year)**.

13.3 Mandatory for both driver and co-driver

13.4 Applicant must hold a **valid Sri Lankan Driving license** to apply for a temporary license.

15.0 Administration

15.1 Organizing clubs must ensure the licenses are surrendered to the secretary of the meet during sign on for the meet.

15.2 SLAS reserves the right to alter, amend or add to these regulations with Council approval.

15.3 License Numbers;

All license numbers are maintained as per the original ministerial directive to preserve national motorsport history.

15.4 Application Forms;

All applications for New and Renewal should be submitted in the prescribed form as attachments (Annexure 1,2,3 & 4) - Published separately.

15.5 Organizing clubs must share the result sheets to the SLAS in detail format. Number of participants and positions of all participants per event.

16.0 Anti-Doping Compliance

Some drivers may be taking a variety of medications, including those for blood pressure and other health conditions. While most of these medications are acceptable, there are certain drugs listed as prohibited substances under the World Anti-Doping Code International Standard 2022.

Drivers are required to sign the "Compliance to Anti-Doping Prohibited List" section on the application form. Any regularly taken medications that may fall under the prohibited substances list should be disclosed to the Ministry of Sports - Institute of Sports Medicine. In certain professional levels of motorsport, drivers may continue to take prohibited substances if they have a valid medical reason.

If a driver fails to declare any medication they are taking, or have started taking, which falls under the prohibited substance categories listed in the annexure of the license application form, and is later found to be using such substances during a spot medical check by the Ministry of Sports, the driver will be subject to appropriate action. However, SLAS will not assume responsibility in this regard.

The responsibility for declaring the need for exemptions from prohibited substances lies solely with the driver. Drivers can submit a request to the Ministry of Sports for a Therapeutic Use Exemption (TUE) through the Institute of Sports Medicine, which allows them to continue their treatment while remaining in compliance with anti-doping rules
